## Mental Health advice for professionals working with children and young people in Tameside and Glossop

Advice	Urgent advice	Emergency advice
<p>Non-urgent concerns regarding a young person's mental health, risk and/or emotional wellbeing.</p>	<p>Urgent concerns regarding a young person's mental health and emotional wellbeing. The young person and those around them are able to be kept safe</p>	<p>Emergency concerns where young person is considered to be at immediate and serious harm to themselves or others.</p>
<p>Discuss in consultation with HMM Neighbourhood practitioner. <i>Professionals must ensure they have consent to discuss the young person.</i></p>	<p><b>SPEAK</b> directly with Neighbourhood Practitioner. If unavailable then contact Tameside Healthy Young Minds Duty Worker on <b>0161 716 3663 Monday-Friday 9am-5pm, or 111 out of hours.</b></p>	<p>Contact Tameside Healthy Young Minds Duty Worker on <b>0161 716 3600 Monday-Friday 9am-5pm. Or call 111 for advice out of hours. If the young person refuses to follow plan then consider contact emergency services. - 999</b></p>
<p>Examples (not exhaustive): Evidence of low mood and/or anxiety, panic, worry.  Low-moderate worries about emotional well-being of a child or feeling unsure about how best to support a child's mental health</p>	<p>Examples (not exhaustive): -Suicidal thinking or significant self-harm. Please follow self-harm pathway to gather more information regarding nature of suicidal thinking. Concerns that a mental health difficulty is causing a significant impact on the ability to carry out daily living activities</p>	<p>Examples (not exhaustive): -Concerns for immediate safety. - Thoughts and plans of suicide. Intent is evident or guarded responses present with questions of plans and intent. -Severe self-harming and/or changes in mental state that could cause harm to self or others.</p>

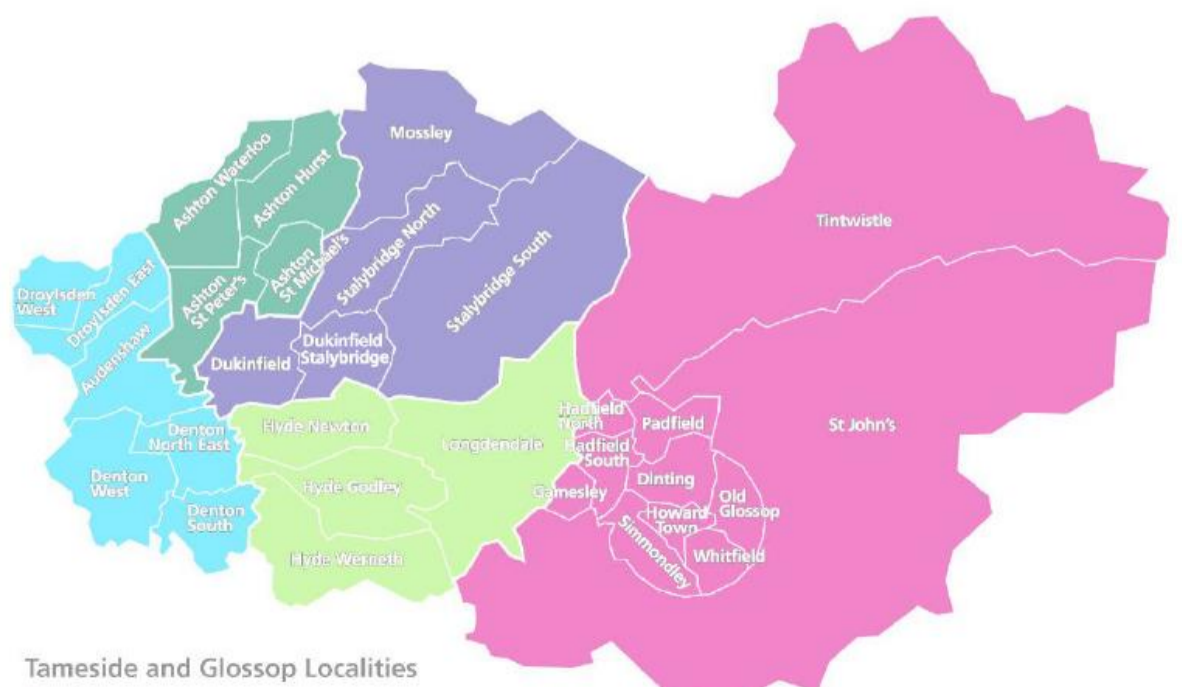
